PRESS RELEASE

The National Garifuna Council (NGC) presents revised MOU to Minister of Constitution & Religious Affairs, Indigenous Affairs, and Transportation and commences a series of branch visits

August 4, 2025 — The National Garifuna Council (NGC) Executive met with the Minister of **Constitution & Religious Affairs, Indigenous Affairs, and Transportation, Hon. Dr. Louis Zabaneh**, to share and discuss a revised Memorandum of Understanding between the NGC and **the Government of Belize (GOB)**. This revision builds on a previous MOU that was signed in 1999 between then Prime Minister of Belize Said Musa and then NGC President Roy Cayetano. This revision strengthens the ten agreements in the previous MOU by incorporating relevant references to Belize's Constitution as well as international **conventions** and declarations related to indigenous peoples in Belize. Present at today's meeting along with Minister Zabaneh were CEO Chester Williams, Director of Indigenous People's Affairs Gustavo Requeña, and Director of Research and Planning Anna Loague. Representing the NGC were President Alex Nolberto, 1st Vice President Raphael Martinez, Assistant Secretary Sharrie Ciego Gordon, and Assistant Treasurer Ifáşínà Efunyemi.

During the discussion with Ministry officials, recommendations were made to further amend and enhance the revised MOU. These included more specific attention to sustainable agricultural and economic development initiatives in Garifuna communities. The revised MOU has seven articles covering areas of recognition and representation, land and environmental rights, cultural and linguistic rights, non-discrimination, inclusive development, and institutional strengthening. Minister Zabaneh explained that after the recommendations from today's meeting are incorporated in the document, it will be shared with the Attorney General for further scrutiny before it is presented to Cabinet for approval.

Today's MOU presentation occurred on the heels of the commencement of a series of branch visits that the newly-elected NGC Executive is conducting in all of NGC's 12 branches across the
